

PUBLIC SERVICE ORDINANCES REPEAL ORDINANCE 1950.⁽¹⁾⁽²⁾

No. 40 of 1950.

An Ordinance to repeal the Public Service Ordinances of the Territory of Papua and the Public Service Ordinances of the Territory of New Guinea.

BE it ordained by the Governor-General in and over the Commonwealth of Australia, with the advice of the Federal Executive Council, in pursuance of the powers conferred by the *Papua and New Guinea Act 1949*, as follows:—

1. This Ordinance may be cited as the *Public Service Ordinances Repeal Ordinance 1950*.⁽¹⁾⁽²⁾ Short title.
2. This Ordinance shall be deemed to have come into operation on the first day of July, One thousand nine hundred and forty-nine. Commencement.
3. The Ordinances specified in the Schedule to this Ordinance are repealed. Repeal.
