

ORDERS IN COUNCIL MADE PURSUANT TO SECTION 2 OF THE EXTRADITION ACT 1870 (UNITED KINGDOM, ADOPTED) WHICH HAVE BEEN EXTENDED TO THE TERRITORY PURSUANT TO SECTION 4 OF THE EXTRADITION ORDINANCE 1927-1933.
