RABAUL BOTANIC RESERVE REGULATIONS 1929. (1)

PART I.—GENERAL.

- 1. These Regulations may be cited as the Rabaul Botanic Reserve Regulations 1929. (1)
 - 2. These Regulations are divided into Parts, as follows:—

Part I.—General.

Part II.—Rabaul Botanic Gardens and Reserve.

Part III.—Town Avenues and Hedges.

- 3. In these Regulations, unless the contrary intention appears:—
 "Director" means the Director of Agriculture.
- 4. The Rabaul Botanic Reserve Regulations, 1928, (2) the Kaewieng Botanic Reserve Regulations 1919, and the Rabaul Botanic Reserve (amendment) Regulations 1919 are hereby repealed.

PART II.—RABAUL BOTANIC GARDENS AND RESERVE.

5. In this Part, the expression the "Reserve" shall mean and include:—

THE SCHEDULE.

6. The Director shall, under the Administrator, be charged with the care and control of the Reserve and of all matters pertaining thereto.

Rabaul Botanic Reserve Regulations 1929.

7. No unauthorised person shall interfere with, damage, destroy, or remove any seat, summer-house, arbour, fence, bridge, culvert, water-tap, water piping, well, road, flower-bed, turf, soil, stove, gardenpot, implement, cart, livestock, meteorological instrument, or any other property in the Reserve.

Penalty: Ten Pounds, or imprisonment for a period of one month.

8. No unauthorized person shall interfere with, cut, damage, destroy, or remove any tree, shrub, grass, fern, flower, fruit, seed, or plant or any part or parts thereof in the Reserve.

Penalty: Ten Pounds, or imprisonment for a period of one month.

9. No unauthorized person shall cut or collect firewood within the Reserve.

Penalty: Five Pounds, or imprisonment for a period of fourteen days.

10. No unauthorized person shall climb any tree, arbour, or summer-house, or climb on, or jump on or over, any seat, fence, or gate, or stick, or otherwise affix any bill, advertisement, or notice on any fence, gate, seat, tree, post or other structure, in or around the Reserve, or cut, paint or write names, letters, or marks on any such tree, seat, gate, post, fence, or other structure, or otherwise injure or deface the same.

Penalty: Five Pounds, or imprisonment for a period of fourteen days.

11. No unauthorized person shall ride, drive, or take any carriage, cart, motorcar, motorcycle, motorlorry, motortractor, bicycle, or other vehicle into, over, or through the Reserve except by way of the portions thereof specially provided for wheeled traffic.

Penalty: Five Pounds, or imprisonment for a period of fourteen days.

12. No person who is not the holder of a licence to drive a motor vehicle shall drive any motor vehicle in the Reserve.

Penalty: Five Pounds, or imprisonment for a period of fourteen days.

13. No person shall drive any vehicle along any roadway in the Reserve at a speed exceeding ten miles per hour.

Penalty: Five Pounds, or imprisonment for a period of fourteen days.

14. No unauthorized person shall ride or lead any horse into, upon, or through the Reserve except on the portions thereof specially provided for equestrians, and no person shall break in, gallop, or train any horse in the Reserve.

Penalty: Two Pounds, or imprisonment for a period of seven days.

15. No unauthorized person shall carry, use, or discharge any firearm in the Reserve.

Penalty: Five Pounds, or imprisonment for a period of fourteen days.

16. No unauthorized person shall take, snare, kill, or wound within the Reserve any pheasant, kookaburra, magpie, peewit, or other bird introduced from Australia or elsewhere, or interfere with the nesting, eggs, or breeding of any such bird.

Penalty: Five Pounds, or imprisonment for a period of fourteen days.

17. No unauthorized person shall take, snare, kill or wound within the Reserve any indigenous bird or animal whether for food or otherwise, or interfere with the nesting, eggs, or breeding of any such bird or animal.

Penalty: Five Pounds, or imprisonment for a period of fourteen days.

18. No unauthorized person shall bring or allow to remain or stray in the Reserve any horse, cattle, sheep, pigs, goats, dogs, or other animals.

Penalty: Five Pounds, or imprisonment for a period of fourteen days.

19. No person shall tie or tether horses, cattle, or any animal, whether attached to a vehicle or not, to any tree, shrub, seat, arbour, summer-house, fence, gate, or building in the Reserve.

Penalty: Two Pounds, or imprisonment for a period of seven days.

20. No person who is in a state of intoxication, or who is disorderly, or who is not decorously dressed shall enter or remain in the Reserve; and no person shall expectorate on any path, seat, or other structure within the Reserve; and no person shall commit any nuisance or offensive act within the Reserve.

Penalty: Five Pounds, or imprisonment for a period of seven days.

21. No person shall convene, call together, hold, attend, or take part in any fete, picnic, or concert, or any assembly for the purpose of public worship, preaching, or public speaking of any kind, or any meeting, or gathering of a like character, in the Reserve without the permission in writing of the Director first had and obtained.

Penalty: Five Pounds, or imprisonment for a period of fourteen days.

22. No unauthorized person shall make any fire or set fire to anything in the Reserve.

Penalty: Five Pounds, or imprisonment for a period of fourteen days.

Rabaul Botanic Reserve Regulations 1929.

23. No person shall erect any booth, tent, or other structure within the Reserve without the consent in writing of the Director.

Penalty: Five Pounds, or imprisonment for a period of fourteen days.

24. No person shall, in any part of the Reserve, wilfully obstruct, disturb, interrupt, or annoy any other person in the proper use of the Reserve or the public conveniences therein erected, or wilfully obstruct in the execution of his duty or insult any keeper or other official employed in or about the Reserve.

Penalty: Five Pounds, or imprisonment for a period of fourteen days.

25. No native shall make use of any garden seat, arbour, summer-house, or other convenience provided for the public in the Reserve, or soil, or disfigure the same.

Penalty: One Pound, or imprisonment for a period of seven days.

26. No person shall deposit any paper, empty tins, refuse, or rubbish of any description in the Reserve.

Penalty: One Pound, or imprisonment for a period of seven days.

27. No person shall sing, shout, play musical instruments, or make other noise or disturbance in the Reserve without the permission of the Director.

Penalty: Five Pounds, or imprisonment for a period of fourteen days.

28. No unauthorized person shall make use of the water, whether from the pipe supply, wells, or streams, in the Reserve.

Penalty: One Pound, or imprisonment for a period of seven days.

29. No unauthorized person shall interfere with or damage any buildings, houses, labourers' quarters, offices, or other buildings in the Reserve.

Penalty: Five Pounds, or imprisonment for a period of fourteen days.

PART III.—TOWN AVENUES AND HEDGES.

- 30. The boundaries of the towns⁽⁵⁾ of Rabaul, Kavieng, Morobe, Madang, Namatanai, Aitape, Lorengau, Kokopo, and Kieta, for the purpose of these Regulations, are as declared under the *Town Boundaries Ordinance* 1924.⁽⁶⁾
- 31. The Director shall have the care and control of all trees, shrubs and plants in the streets, and roads of the Township of Rabaul, and of all hedges around Administration offices, and all grass plots,

plantations, parks, gardens, set apart for the use of the public, except where such areas as have been, or may be, handed over to trustees or other persons specially appointed for the purpose, within the township of Rabaul.

32. The Director shall have the care and control of all trees on Administration land in the township of Rabaul, and no person shall fell, ring, cut or damage any such tree without the written consent of the Director having first been had and obtained.

Penalty: One Pound, or imprisonment for a period of seven days.

33. No unauthorized person shall fell, ring, cut, damage, remove or otherwise interfere with any tree, shrub, plant, hedge, on any public street, road, park or garden:

Provided always that, in the case of any tree or portion of a tree breaking or falling, on account of storm, or other natural agency, and obstructing or being dangerous to traffic, such may be removed by any person, who should then notify the Director in Rabaul or, on an outstation, the District Officer.

Penalty: Ten Pounds, or imprisonment for a period of twenty-one days.

34. No unauthorized person shall climb any tree or ride or drive through or over any grass plot, plant, shrub, or hedge, in any public street, road, or throw any stone or missile or any refuse, or rubbish into or upon any such street or road, or any tree, grass, plot, plant, shrub, or hedge thereon.

Penalty: Five Pounds, or imprisonment for a period of fourteen days.

35. No person shall cut, paint, or place names, letters or marks on, or stick or otherwise affix notices, bills, or advertisements on or to any tree in any public street, road, park or garden.

Penalty: Five Pounds, or imprisonment for a period of fourteen days.

36. No unauthorized person shall fasten or tether any animal, whether attached to a vehicle or not, to any tree, shrub, seat, fence, gate or post, on any public street, road, park or garden; but this Regulation shall not apply to any rail, post, or peg specially erected for such purpose.

Penalty: Five Pounds, or imprisonment for a period of seven days.

37. No native shall use any seat, or other convenience provided for the use of the public in any public street, road, park, or garden, or soil, or disfigure the same.

Penalty: One Pound, or imprisonment for a period of seven days.
