

MARRIAGE REGULATIONS.⁽¹⁾

Regulations 1936, No. 1.

Short title.

1. These Regulations may be cited as the *Marriage Regulations*.⁽¹⁾

Form of consent to marriage of minor.

2.—(1.) The written consent referred to in paragraph (a), (b), or (c) of sub-section (1.) of section 13 of the *Marriage Ordinance* 1935⁽²⁾ shall be in accordance with Form 1 in the Schedule to these Regulations.

(2.) The written consent referred to in paragraph (d) of sub-section (1.) of section 13 of the *Marriage Ordinance* 1935⁽²⁾ shall be in accordance with Form 2 in the Schedule to these Regulations.

Fee.

3. A fee of One pound shall be paid to a District Registrar on or before the celebration of any marriage by him under the provisions of the *Marriage Ordinance* 1935.⁽²⁾
