# ARRANGEMENT OF SECTION.

Organic Laws (Amendment of Section 12).

## INDEPENDENT STATE OF PAPUA NEW GUINEA.

Constitutional Amendment No. 26 - Organic Laws,

Being a Law to alter the *Constitution* by amending the provision relating to Organic Laws,

MADE by the National Parliament, to be deemed to have come into operation on 16 September 1975.

### ORGANIC LAWS (AMENDMENT OF SECTION 12).

Section 12 of the *Constitution* is amended –

(a) by repealing Subsection (1) and replacing it with the following:-

"(1) Subject to Subsection (4), for the purposes of this Constitution, an Organic Law is a law made by the Parliament that is –

- (a) for or in respect of a matter provision for which by way of an Organic Law is authorized by this Constitution; and
- (b) not inconsistent with this Constitution; and
- (c) expressed to be an Organic Law."; and

(b)

#### by adding the following new subsection:-

"(4) Where this Constitution authorizes an Organic Law to make provision for any matter, the Organic Law may -

make full provision for all aspects of that matter notwithstanding that all such aspects have not been expressly referred to in the provision authorizing the Organic Law except where this Constitution expressly limits the aspects of that matter for which provision may be made in an Organic Law; and

may impose conditions, restrictions or modifications in respect of that matter or any aspect of it, except where this Constitution expressly states that conditions, restrictions or modifications shall not be imposed in respect of that matter.".
