The Principal Act is amended by inserting after Section 4 the following new section:-

"4A. APPOINTMENT OF COUNSEL AND TECHNICAL AND PROFESSIONAL EXPERTS TO ASSIST THE COMMISSION.

- (1) The Minister may appoint one or more counsel to assist the Commission in the performance of its duties.
- "(2) Where the Minister is of the opinion that the subject of an inquiry warrants it, he may appoint one or more persons with appropriate technical or professional expertise to assist the Commission.".

2. PENALTY FOR FAILING TO ATTEND OR PRODUCE DOCUMENTS (AMENDMENT OF SECTION 9).

Section 9(1) of the Principal Act is amended by repealing the penalty clause and replacing it with the following:-

"Penalty: A fine not exceeding K5,000.00 or imprisonment for a term not exceeding two years, or both.".

3. PENALTY FOR REFUSING TO BE SWORN OR GIVE EVIDENCE (AMENDMENT OF SECTION 10).

Section 10 of the Principal Act is amended by repealing the penalty clause and replacing it with the following:-

"Penalty: A fine not exceeding K5,000.00 or imprisonment for a term not exceeding two years, or both.".

4. CONTEMPT OF COMMISSION (AMENDMENT OF SECTION 11).

Section 11 of the Principal Act is amended by repealing the penalty clause and replacing it with the following:-

5. PRESERVATION OF SECRECY (AMENDMENT OF SECTION 12).
Section 12 of the Principal Act is amended by repealing the penalty clause and replacing it with the following:-

"Penalty: A fine not exceeding K5,000.00 or imprisonment for a term not exceeding two years, or both.".
