Being an Act to amend the Income Tax, Dividend (Withholding) Tax and Interest (Withholding) Tax Rates Act (Chapter 111),

MADE by the National Parliament to come into operation on 1 January 2002.

#### 1. NEW SECTION 1A.

The Principal Act is amended by inserting after Section 1 the following new section: –

#### "1A. FISCAL STABILITY.

Where a taxpayer is subject to fiscal stability under the provisions of the *Resource Contracts Fiscal Stabilisation Act* 2000 then, notwithstanding any other provisions of this Act, the tax rates applicable to that taxpayer shall be those which are or were in force at the time the fiscal stability period commenced and shall continue to apply to that taxpayer at those rates until the expiry of that fiscal stability period."

#### 2. AMENDMENT OF SCHEDULE 1.

Schedule 1 of the Principal Act is amended by repealing the Table and replacing it with the following:—
