Being an Act to amend the Income Tax, Dividend (Withholding) Tax and Interest (Withholding) Tax Rates Act 1984,

MADE by the National Parliament and deemed to come into operation on 1 January 2017.

- RATE OF TAX PAYABLE BY FOREIGN CONTRACTORS (AMENDMENT OF SECTION 6A).
 Section 6A of the Principal Act is amended by repealing the words "of the taxable income".
- 2. RATE OF DIVIDEND (WITHHOLDING) TAX (AMENDMENT OF SECTION 10). Section 10 of the Principal Act is amended by repealing and replacing it with the following:

"The rate of dividend (withholding) tax payable in respect of dividends (other than unit trust dividends) paid by a resident company is 15 percent.".

3. MINING, PETROLEUM AND GAS INCOME.

Schedule 4 of the Principal Act is amended in Schedule 4.4 by repealing Subsection (1) and replacing it with the following new subsection:

"(1) The rate of tax in respect of income from mining, petroleum and gas operations is 30 percent of the taxable income, which is applicable to the 2017 year of income and each subsequent year of income."
