*Papua New Guinea Act 1949-1974 of Australia***WARRANT****REMISSION OF SENTENCE**

To: The Commissioner of Corrective Institution, and

To: Each Officer in Charge of each Corrective Institution specified in Column 1 of the Schedule.

WHEREAS each offender specified in Column 2 of the Schedule committed an offence against a law of Papua New Guinea and was duly convicted and sentenced under a law of Papua New Guinea by a Court exercising criminal jurisdiction in Papua New Guinea:

AND WHEREAS each of those offenders was sentenced to a period of imprisonment of 12 months or more and, but for the grant of this remission, would be due for release on or before 31st December, 1975;

AND WHEREAS on 16th September, 1975 Papua New Guinea will celebrate and achieve its Independence and the Government of Papua New Guinea and I desire to commemorate this occasion by partially remitting the unexpired portion of the sentence of each of those offenders which remains unserved on and from 15th September, 1975:

NOW THEREFORE I, THOMAS KINGSTON CRITCHLEY, High Commissioner, by virtue of the powers conferred by Section 73 of the *Papua New Guinea Act 1949-1974 of Australia* and all other powers me enabling, hereby grant to each of those offenders a remission for so much of the unexpired sentence of imprisonment as remains unserved on 15th September, 1975.

Petroleum (Submerged Lands) Act 1975

PROCLAMATION

I, THOMAS KINGSTON CRITCHLEY, High Commissioner, by virtue of the powers conferred by Section 2(3) and (5) of the *Petroleum (Submerged Lands) Act 1975*, and all other powers me enabling, and having received the advice of the Executive Council, hereby—

- (a) revoke the proclamation dated 7th April, 1975 published in *Government Gazette* No. 31 of 24th April, 1975; and
- (b) proclaim and declare that the area described in Schedule 1 forms part of the offshore area, to the extent that the area includes—
 - (i) areas of territorial waters; and
 - (ii) areas of superjacent waters of the continental shelf; and
- (c) proclaim and delimit the offshore area in part in accordance with the line of delimitation described in Schedule 2.

SCHEDULE 1

Description of Declared Offshore Area.

A line of delimitation commencing at a point of latitude 9 degrees 52 minutes south longitude 140 degrees 29 minutes thence north-easterly along the rhumb line to a point of latitude 9 degrees 24 minutes 30 seconds south longitude 140 degrees 49 minutes 30 seconds east thence north-easterly along the rhumb line to a point of latitude 9 degrees 23 minutes south longitude 140 degrees 52 minutes east thence north-easterly along the rhumb line that terminates at a point of latitude 9 degrees 8 minutes 8 seconds south longitude 141 degrees 1 minute 10 seconds east to its intersection by the coastline at mean low water (or if at any time that last mentioned rhumb line is not intersected by the coastline at mean low water then to the point of latitude 9 degrees 8 minutes 8 seconds south longitude 141 degrees 1 minute 10 seconds east thence northerly along the meridian of longitude 141 degrees 1 minute 10 seconds east to its intersection by the coastline at mean low water).
