IT is hereby notified for public information that the Bank of Papua New Guinea, under Regulation 27 of the Foreign Exchange Regulations, has exempted from the application of Regulation 13 of those Regulations any person who has applied to be regarded, for exchange control purposes, as a temporary resident of Papua New Guinea and has received approval from the Bank of Papua New Guinea or an authorised dealer, provided that such approval is currently valid.

The effect of the foregoing Exemption is that persons who have been granted temporary residential status for exchange control purposes may acquire, dispose of or otherwise deal with any foreign securities without the authority of the Bank of Papua New Guinea.
