## NOTICE OF VALUE PER UNIT OF CROCODILE SKINS

I, JOHN GUISE, G.C.M.G., Governor-General, by virtue of the powers conferred by Section 1 of the *Customs (Export) Tariff 1974*, and all other powers me enabling, acting with, and in accordance with, the advice of the National Executive Council, hereby declare that, for the purposes of that Act—

- (a) the export value of crocodile skins shall be K3.00 per inch belly-width or per inch hornback-width; and
- (b) "export value" means the value per unit of a prescribed unprocessed natural resource; and
- (c) "belly-width" means the distance across the skin of the abdomen of a crocodile between the innermost edges of the rows of lateral scutes on either side of the abdomen measured between the pair of scutes third from the head; and
- (d) "hornback-width" means the distance across the skin of the back of the crocodile from one cut edge on the midline of the belly to the other cut edge.
