## WEWAK

Made by the Deputy price Conroller under the provisions of the Prices Regulation Act 1949, to come into operation on the date of publication in the National Gazette.

#### 1. CITATION.

This Order may be cited as Prices Order No. 173.

## 2. REVOCATION.

Prices Order No. 136 is hereby revoked.

## 3. **DEFINITIONS.**

In this Order-

"bread" means a product obtained by baking a yeast leavened dough prepared with flour and water with or without other ingredients;

- "ordinary bread" means bread made into loaves other than starch-reduced bread, protein-increased bread or milk bread as defined in this Order or fancy bread;
- "milk bread" means bread which is made into loaves and which contains no less than four parts per centum by weight of non-fat milk solids calculated on the water-free substance;
- "starch-reduced bread" or "protein increased bread" means bread which is made into loaves and which contains not less than two and seven-tenths part per centum by weight of nitrogen calculated on the water-free substance;
- "unwrapped" in relation to the sale of any bread means that such bread is not wrapped as defined in this Order;

"wrapped" means in relation to the sale of any bread that such bread is fully enclosed prior to delivery to the place at which the bread is sold by retail, in waxed or grease-proof paper, cellulose film, polythene or other similar wrapping and that such bread was so enclosed when sold;

"foil-wrapped" means in relation to the sale of any bread that such bread is fully enclosed prior to delivery to the place at which the bread is sold by retail, in aluminium or other foil, and that such bread was so enclosed when sold.

## 4. MEASUREMENT OF WEIGHT.

Where, in this Order, the maximum price fixed is related to the weight of bread, the weight is to be measured when the bread is cold.

## 5. MAXIMUM PRICE

The maximum price at which bread included in a category described in the first column of the Schedule to this Order may be sold by retail in the town of Wewak to be the price specified in the second column of that Schedule opposite to the description of that category.

## 6. DISPLAY OF PRICES

A person or organisation engaged in selling bread by retail in the town of Wewak, shall display in each of their places of business, in prominent positions and in large clear and legible figures, the types of bread loaves covered by this Order and the prices at which such loaves may be bought.

  - (2) The Company will comply with all and any obligations and conditions relating to the training of employees and the localisation of the staff (including both employees and officers of the Company) which may from time to time be laid down by the Department of Labour and Industry (or any other Department which succeeds to the functions of that Department) or prescribed under the *Employment (Training and Regulation) Act* 1971 or under any other Act dealing with training and localisation of employees.
  - (3) The Company shall consult with Papua New Guinean employees before management decisions relating to the terms and conditions of their employment are made.
- 8. Environmental Control and Management
  - (1) The Company will at all times conduct its operations in such a way as to minimise deleterious effects on the environment, it will abide by any laws regulations as shall from time to time deal with environmental control or management or in the absence of any such laws or regulations the Company shall abide by any reasonable standards which may be specified by the Minister responsible for environment matters.
  - (2) Any conditions relating to environmental matters contained in any lease granted to the Company shall be deemed to be a term and condition of registration.
- 9. Pest Control
  - (1) The Company shall observe and carry out all pest control requirements of the Government from time to time relating to the importation and storage of wheat.
- 10. Prices
  - (1) The Company shall at all times maintain its prices for all types of flour and stock feed produced in Papua New Guinea for such periods and at such levels as are required from time to time by the Prices Commissioner under the Prices Regulation Act 1949.
- 11. Import Controls and Protection
  - (1) If the Company desires to apply to the Government for the implementation of any import control or protection then—
    - (a) upon application to the Government at any time prior to the commencement of production NIDA shall, if satisfied that import controls or protection are necessary to the economic viability of the industry, recommend to the Minister for Foreign Relations and Trade such import controls or protection for the industry as the Minister deems necessary or sufficient;

- (b) at any time after commencement of production the Company may, without the approval of NIDA, apply for such protection or import controls as are necessary to the economic viability of the industry for a period not exceeding two years.
- (2) The Company shall not, without prior approval of NIDA:
  - (a) apply for protection or import controls for a period exceeding two years;
  - (b) in the event that upon application by the Company protection or import controls are granted to the Company for a period not exceeding two years, apply for extension of that period.
- 12. Additional Conditions
  - (1) The Company shall-

    - (b) encourage and assist Papua New Guinean enterprises in establishing businesses in ancillary activities:

    - (d) provide all new infrastructure required or compensate the Government for any new specific infrastructure provided by it in the form of equity or such other means as are agreed by the Company and the Government;
    - (e) provide export marketing or access to export markets, where the Government considers it appropriate;
    - (f) in drawing up of all agreements and arrangements for the provision of goods and services, utilise ruling market prices as the basis for determining cost:
    - (g) keep all the books of account and records of the Company in Papua New Guinea and in the English language.
  - (2) Subject to the Act, the registration of the Company is for a period of 15 years from the date of registration but may be extended from time to time by the Minister on the application of the Company.
  - (3) The Company shall not register any transfer of its shares without the prior approval of NIDA.
  - (4) Any application by the Company for the approval of, or a determination by the Minister, required by or to be given in accordance with any of these terms and conditions shall be made in writing to NIDA.
