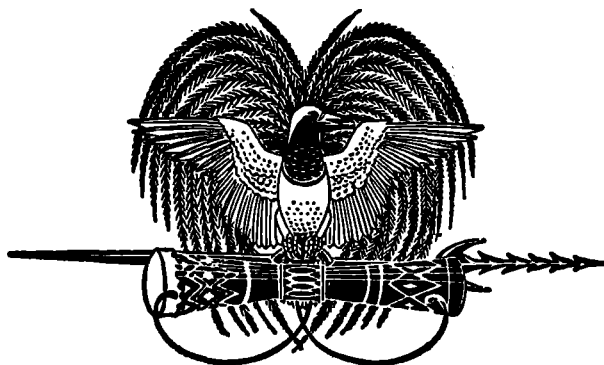

## PRICES ORDER No. 177

being

A PRICES ORDER relating to the maximum prices for

## POULTRY

MADE by the Price Controller under the provisions of the *Prices Regulation Act 1949*, to come into operation on the date of publication in the *National Gazette*.

## 1. CITATION.

This Order may be cited as Prices Order No. 177.

## 2. DEFINITIONS.

In this Order—

"poultry" means poultry other than ducks, geese and turkeys and includes fresh or frozen dressed and packaged poultry, whether whole or in pieces and whether locally produced or imported.

"cost into store" in relation to poultry originally purchased in Papua New Guinea, means the cost of that poultry obtained by adding the following amounts:—

- (a) the original purchase price paid or payable to a wholesaler or a producer in Papua New Guinea; and
- (b) freight (by sea or air), transport (by road), wharfage and handling and insurance charges actually incurred from the producer's place of business to the original purchaser's store;

"landed cost" in relation to poultry purchased in a place other than Papua New Guinea, means the cost of that poultry to the purchaser obtained by adding the following amounts:—

- (a) the purchase price paid or payable;
- (b) buying commission actually incurred, and payable to a source not connected with the purchaser, not exceeding two and a one-half *per centum* (2½%) of the price referred to in paragraph (a);
- (c) import and export duties, taxes, or levies actually incurred (if any);
- (d) charges actually incurred for freight by sea to the port of entry, insurance and exchange (if any);
- (e) stevedoring and wharfage charges actually incurred at the port of entry, but excluding demurrage and storage charges; and
- (f) charges actually incurred for preparation of customs import entries (if any); and
- (g) charges actually incurred for bank drafts and bills (if any); and
- (h) transport charges actually incurred from wharf at the port of entry in Papua New Guinea to the purchaser's store.

## 3. WHOLESALE SALES.

Subject to this Order the Maximum price at which poultry may be sold wholesale is the sum of the following amounts:

- (a) the cost into store or the landed cost (as the case may be) of that poultry; and
- (b) twelve and one-half *per centum* (12½%) of the cost referred to in paragraph (a); and
- (c) an allowance at the rate of 8 toea a kilogram or part of a kilogram calculated in relation to the weight of the poultry concerned.

**Prices Order No. 177—continued****4. RETAIL SALES OF POULTRY PURCHASED FROM A WHOLESALER IN PAPUA NEW GUINEA.**

Subject to this Order where a person has bought poultry from a wholesaler in Papua New Guinea the maximum price at which he may sell that poultry in Papua New Guinea by retail is the "cost into store" plus seventeen and one-half *per centum* (17½%) of that cost.

**5. RETAIL SALES OF POULTRY IMPORTED DIRECT BY SELLER OR PURCHASED FROM LOCAL PRODUCER.**

Subject to this Order where a person has imported poultry or purchased poultry from a producer in Papua New Guinea, the maximum price at which he may sell that poultry in Papua New Guinea by retail is the sum of the following amounts:—

- (a) the "landed cost" or "cost into store" of that poultry; and
- (b) thirty three *per centum* (33%) of the cost referred to in paragraph (a); and
- (c) an allowance at the rate of 8 toea a kilogram or part of a kilogram calculated in relation to the weight of the poultry concerned.

**6. CALCULATION OF PRICES.**

Where the maximum wholesale or retail price (of any quantity supplied at any one time) of poultry, calculated in accordance with this Order, is an amount involving a fraction of one toea, that fraction may be treated as one toea.

**7. DISPLAY OF PRICES.**

A person or organisation who has in his custody or under his control any poultry for sale by retail, or who offers, exhibits or exposes any of that poultry for sale by retail, shall display a ticket, label, placard or notice attached to or exhibited or displayed with the poultry setting forth in a prominent position in clear and legible figures easily discernible to any person inspecting such poultry, the price at which the poultry concerned may be bought.

A PRICES ORDER relating to the maximum prices for

**POULTRY—PORT MORESBY**

MADE by the Price Controller under the provisions of the *Prices Regulation Act 1949*, to come into operation on the date of publication in the *National Gazette*.

**1. CITATION.**

This Order may be cited as Prices Order No. 178.

**2. REVOCATION.**

Prices Order No. 165 and Prices Order No. 166 are hereby revoked.

**3. DEFINITIONS.**

In this Order—

"poultry" means fresh or frozen dressed and packaged chickens produced in Papua New Guinea.

**4. MAXIMUM PRICES.**

Notwithstanding the provisions of Prices Order No. 177, the maximum price per bird at which poultry may be sold by wholesale and retail in the city of Port Moresby is the amount specified in Column 2 of the Schedule in relation to the size of each bird specified opposite in Column 1 of the Schedule.

**5. DISPLAY OF PRICES.**

A PRICES ORDER relating to the maximum prices for

## POULTRY—LAE

MADE by the Price Controller under the provisions of the *Prices Regulation Act 1949*, to come into operation on the date of publication in the *National Gazette*.

## 1. CITATION.

This Order may be cited as Prices Order No. 179.

## 2. REVOCATION.

Prices Order No. 165 and Prices Order No. 166 is hereby revoked.

## 3. DEFINITIONS.

In this Order—

"poultry" means fresh or frozen dressed and packaged chickens produced in Papua New Guinea.

## 4. MAXIMUM PRICES.

Notwithstanding the provisions of Prices Order No. 177, the maximum price per bird at which poultry may be sold by wholesale and retail in the city of Lae is the amount specified in Column 2 of the Schedule in relation to the size of each bird specified opposite in Column 1 of the Schedule.

## 5. DISPLAY OF PRICES.

A person or organisation who has in his custody or under his control any poultry for sale by retail, or who offers, exhibits or exposes any of that poultry for sale by retail, shall display a ticket, label, placard or notice attached to or exhibited or displayed with the poultry setting forth in a prominent position in clear and legible figures easily discernible to any person inspecting such poultry, the prices at which the poultry concerned may be bought.
