Liquor (Licensing) Act 1963

RESTRICTION OF SALE AND SUPPLY OF LIQUOR

I, Pita Lus, Minister for Corrective Institutions and Liquor Licensing, by virtue of the powers conferred by Section 31 of the Liquor (Licensing) Act 1963, and all other powers me enabling, hereby restrict or limit, as the case may be-

- (a) notwithstanding the notice of Restriction of Sale and Supply of Liquor dated 30th March, 1977 and published in *National Gazette* No. G32 of 7th April, 1977 and the Liquor Licensing (Trading Hours) Rules 1975; and
- (b) throughout Papua New Guinea; and
- (c) subject to the exceptions specified in the Schedule,

the sale or supply of liquor under any publican's licence, club licence, tavern licence or canteen licence-

- (d) on 16th June, 1977; and
- (e) on 17th June, 1977; and

(f) on 18th June, 1977,

except between the hours of 6.30 p.m. and 9.30 p.m.

SCHEDULE

Exceptions

The provisions of this notice do not apply-

(a) the holder of a publican's licence who may supply liquor-

(i) for consumption on licensed premises at any time to lodgers; and

- (ii) for consumption on licensed premises as part of a meal during the hours when such supply would ordinarily be permitted; and
- (iii) under a cabaret permit, supper permit or permit granted under Section 76 of the Act; and
- (b) the holder of a club licence who may supply liquor-
 - (i) for consumption on licensed premises as part of a meal during the hours when such supply would ordinarily be permitted; and
 - (ii) under a supper permit or a permit granted under Section 76 of the Act; and
- (c) the holder of a tavern licence who may supply liquor under a permit granted under Section 76 of the Act.

Liquor (Licensing) Act 1963

RESTRICTION OF SALE AND SUPPLY OF LIQUOR

I, Pita Lus, Minister for Corrective Institutions and Liquor Licensing, by virtue of the powers conferred by Section 31 of the *Liquor (Licensing) Act* 1963, and all other powers me enabling, hereby restrict or limit the sale or supply of liquor throughout Papua New Guinea under a storekeeper's licence or bottleshop licence during the month of June in 1977 to 1st—15th June (inclusive) and 25th—30th June (inclusive).

Liquor (Miscellaneous Provisions) Act 1973

DECLARATION OF PUBLIC PLACES

I, Pita Lus, Minister for Corrective Institutions and Liquor Licensing, by virtue of the powers conferred by Section 9 of the Liquor (Miscellaneous Provisions) Act 1973, and all other powers me enabling, hereby declare all public places in Papua New Guinea (other than premises which are the subject of a licence or permit under the Liquor (Licensing) Act 1963) to be public places to which the provisions of Section 9 of the Act apply as specified in the Schedule.

SCHEDULE

Between the hours of 2 a.m. and 6 p.m. on the following days-

(a) 16th-18th June, 1977 (inclusive); and

(b) 20th-25th June, 1977 (inclusive); and

(c) 27th June-2nd July, 1977 (inclusive); and

(d) 4th-9th July, 1977 (inclusive).
