Organic Law on Provincial Government

CHARTER

GRANTING PROVINCIAL GOVERNMENT TO THE MOROBE PROVINCE

WHEREAS

(1) by notice published in the National Gazette on 12th May, 1977 the Minister responsible for provincial affairs (hereinafter called "the Minister") recognized, for the purposes of the Organic Law on Provincial Government (hereinafter called "the Organic Law") and of Section 187B of the National Constitution (grant of Provisional Government), a constituent assembly for the Morobe Province; and

(2) the Minister has, on behalf of the National Government, consulted with that constituent assembly on a constitution for the Province and on the granting of provincial government to the Province; and

(3) the National Parliament, by an absolute majority vote, on 15th November, 1977 on the motion of the Minister, resolved that the National Executive Council be authorized to approve the grant of provincial government, and the granting of a Charter under Section 6 of the Organic Law to the Morobe Province; and

4) the provincial constituent assembly for the Morobe Province on 16th December, 1977 adopted, in accordance with Part III of the Organic Law, a constitution for the Morobe Province that is not inconsistent with the National Constitution or the Organic Law; and

(5) the National Executive Council has advised me to grant provincial government to the Morobe Province,

NOW THEREFORE I, Tore Lokoloko, G.C.M.G., Governor-General, by virtue of the powers conferred by Section 6 of the Organic Law and all other powers me enabling, acting with, and in accordance with, the advice of the National Executive Council, by this Charter grant, in the name and on behalf of the Independent State of Papua New Guinea, provincial government to the Morobe Province.

National Investment and Development Act 1974

NOTIFICATION OF APPROVAL OF REGISTRATION

IT is hereby notified in accordance with Section 54(12) of the National Investment and Development Act 1974 that-

- (a) under Section 54(9) of the Act the Minister approved registration of W. J. & K. L. Richardson trading as Supreme Fisheries (in this notification called "the Enterprise") in respect of the following activities:
 I.S.I.C. No. 3114—Canning, preserving and processing of fish, crustacea and similar foods:
 - Management and technical services only

I.S.I.C. No. 6100-Wholesale trade:

Fish, crustacea and other fish products

subject to the conditions specified in the Schedule; and

- (b) under Section 54(11)(a) of the Act the Minister directed NIDA to register the Enterprise; and
- (c) the Enterprise was registered on 20th February, 1978.

SCHEDULE

Conditions of Registration—Supreme Fisheries

1. Words and expressions which have a certain meaning in the National Investment and Development Act 1974 as amended from time to time (hereinafter called "the Act") shall have the same meaning as in the Act and "fish" and "fishing" shall have the same meaning as in the Fisheries Act 1974, where used in these terms and conditions.

2. The Enterprise shall keep all its books of account and records relating to its Papua New Guinean activities in Papua New Guinea and in the English language.

3. Not later than 30th June, 1977, the Enterprise shall enter into an agreement with the Company (hereinafter called "the Management Agreement"), which will provide amongst other things for the following:

- (a) Subject to the other provisions of the Management Agreement, the Enterprise will act as the managing agents of Western District Seafoods Pty Ltd (hereinafter called "the Company") for a period of ten years.
- (b) The Enterprise shall, subject to directions from the Board of Directors of the Company given from time to time, have responsibility for but not limited to—
 - (i) management of the Company's cash flow;
 - (ii) ensuring that the Company has sufficient funds to carry on its normal day to day activities;
 - (iii) preparation of periodic budgets for presentation to the Board of Directors;
 - (iv) the keeping of all necessary books and accounts whether required by law or good commercial practice; and
 - (v) recommending the payment of dividends to the Board of Directors, but with no authority without the consent of the Board of Directors to—
 - (vi) borrow money on account of the Company;
 - (vii) sell any property or assets of the Company;
 - (viii) invest (otherwise in short term deposits or securities made or otherwise acquired to give temporary employment to idle funds) any funds of the Company;
 - (ix) commit the Company to any capital expenditure over K5 000;
 - (x) mortgage, charge, pledge or otherwise encumber any of the property or assets of the Company; or
 - (xi) give any guarantee or indemnities on behalf of the Company except as may be necessary in the ordinary course of business in connection with purchases and sales of goods by the Company.
- (c) The Enterprise shall on behalf of the Company-
 - (i) prepare plans for the construction of a fish processing facility at Daru in the Western Province;
 - (ii) ensure that the plans are submitted to the appropriate government departments and agencies for all necessary consents and approval;
 - (iii) submit the plans to the Department of Primary Industry for its review and comment;
 - (iv) once the plans have received all necessary consents and approvals, place orders with appropriate suppliers for the supply and delivery to Daru of materials and equipment required for the construction of the fish processing facility;
 - (v) supervise the construction of the fish processing facility; and
 - (vi) ensure that the suppliers of equipment for the fish processing facility give warranties in relation to the performance of the equipment of a type normally expected in the fishing industry and that such warranties are available directly to the Company.
- (d) The fish processing facility will be ready for use by 30th September, 1978. Any loss suffered by the Company after six months of operation of the fish processing facility which is a result of faulty design or construction of the facility and which renders the fish produce of the Company unacceptable for the export market will be borne by the Enterprise and may be recovered by the Company as a debt due and owing to it by the Enterprise.
- (e) The Enterprise shall provide or recruit for the Company-
 - (i) a manager, who shall be the chief executive of the Company resident in Daru and who shall take up his duties within one month of the date of the Management Agreement; and
 - (ii) a field officer who shall be responsible for encouraging the development of local fishing in the Western Province and the improvement of the fishing and catch holding techniques of the local fishermen and who shall take up his duties within three months of the date of the Management Agreement.

Schedule—continued

The manager and the field officer shall be responsible to the Enterprise for the carrying out of its functions as managing agent under the Management Agreement but shall also be subject to the general directions of the Board of Directors of the Company from time to time.

- (f) The Enterprise shall on behalf of the Company prepare and submit to the Department of Labour, Commerce and Industry within three months of the date of the Management Agreement a training and localisation programme which will be consistent with the *Employment (Training and Regulation) Act* 1971 and any regulations and declarations made thereunder and which will contain detailed job descriptions of each position intended to be filled by an expatriate.
- (g) The Enterprise shall make available to the Company such general advice and information as the Company may from time to time reasonably require in respect of—
 - (i) fishing operations and fisheries extension work;
 - (ii) personnel recruitment, training and management;
 - (iii) commercial practices and financial methods;
 - (iv) accounting procedures; and
 - (v) the procurement of goods and services.
- (b) Within eighteen months of the date of the Management Agreement, the Enterprise shall advise the Company on measures required from time to time to avoid damage or pollution to the environment arising from the operation of the processing plant.
- (i) The Enterprise shall ensure at all times during the term of the Management Agreement that there shall be no damage to or pollution of the environment as a result of the operation of the fish processing facility.
- (*j*) The earnings related fee shall be payable in the next succeeding financial year after the financial year for which it is calculated and shall be paid only if in that next succeeding financial year the Company is first able to meet all its obligations to repay the principal of or pay interest on its loans.
- (k) The parties to the Management Agreement shall review its operation at the end of the first, second, third, sixth and ninth years of its duration and if upon such review difficulties in its continued operation to the mutual benefit of both parties shall appear, the parties shall negotiate in good faith with a view to reaching agreement on satisfactory alternative arrangements.
- (1) The Management may be terminated by the Company at any time if—
 - (i) the fish processed in the fish processing facility does not meet all Papua New Guinea Department of Primary Industry standards and fish processed for local sales within PNG do not meet local health standards; or
 - (ii) the Company does not return a net pre-tax profit for the financial year 1978/1979; or
 - (iii) the Company's loans are not repaid as they fall due; or
 - (iv) the Enterprise fails to perform its functions under the Management Agreement; or
 - (v) the registration of the Enterprise under the Act ceases.

4. Not later than 30th June, 1977, the Enterprise shall enter into an Agreement with the Company (hereinafter called "the Marketing Agreement") which will provide amongst other things for the following:

- (a) The Enterprise as managing agent of the Company shall seek out buyers for the Company's fish and fish products and shall arrange sales on behalf of the Company.
- (b) The Enterprise shall not itself purchase the fish and fish products of the Company unless it can demonstrate to the Board of Directors of the Company that the prices which it is prepared to pay to the Company are not less than prices which could be obtained elsewhere.
- (c) All invoices, statements of account and other documents received by the Enterprise as a result of sales of the fish and fish products of the Company will be submitted to the Board of Directors of the Company together with a quarterly summary of sales negotiated, quantities sold and prices received.
- (d) The Company shall pay to the Enterprise in respect of the abovementioned services a fee of $2\frac{1}{2}$ % of the gross revenue of the Company in each financial year being the value of f.o.b. at port of export from Papua New Guinea or at point of sale within PNG of all products of the Company sold in the financial year.
- (e) All sales contracts negotiated by the Enterprise on behalf of the Company will be at arms length and will not involve the payment to the Enterprise of any commissions or fees or any indirect benefits for the Enterprise, other than the fee referred to in paragraph (d).
- (f) The Marketing Agreement shall terminate upon the expiration of the term of the Management Agreement or its sooner termination for any cause.

5. The Enterprise shall not carry on in Papua New Guinea the activities for which it is registered other than by the provision of services to the Company under the Management and Marketing Agreements.

6. Subject to the Act and to Condition 7, the registration of the Enterprise is for the duration of the Management Agreement.

7. The Minister, after receiving a report from NIDA may recommend to the High Commissioner in counsel to cancel the registration of the Enterprise if any of the events specified in Condition 3(1)(i), (ii) and (iii) occur.

2. Any application by the Enterprise for approval of, or a determination by, the Minister required by or to be given in accordance with any of these terms and conditions shall be made in writing to NIDA.

3. The Enterprise shall keep all its books of account and records in Papua New Guinea and in the English language.

4. The Enterprise shall comply with all and any obligations and conditions relating to the employment of noncitizens, training of employees and the localisation of its staff (including both employees and officers of the Enterprise) which may from time to time be laid down by the Department of Labour and Industry (or any other Department which succeeds to the functions of that Department) or prescribed or declared under the Employment (Training and Regulation) Act 1971 or under any other Act dealing with employment of non-citizens, training and localisation of employees.

5. Unless otherwise determined by the Minister, Papua New Guineans or local enterprises shall by the third anniversary of the date of registration and at all times thereafter hold and beneficially own shares having the right to not less than 26% of the votes at a general meeting of the Enterprise and the right to appoint directors of the Enterprise not less than in proportion to their equity holding.

6. Subject to the Act, the registration of the Enterprise is for five years from the date of registration but may be extended from time to time by the Minister on the application of the Enterprise.

7. If at the expiration of six months from the date of registration the Enterprise has not commenced carrying on business in any of the activities for which it is hereby registered, the registration of the Enterprise shall thereupon cease and determine in respect of those activities.

8. The Enterprise shall use sources of supply and services within Papua New Guinea, preferably Papua New Guinean owned, unless the required supplies and services are not readily available at comparable prices and of similar quality in Papua New Guinea.

9. The Enterprise shall not register any transfer of its shares until NIDA has been notified in writing of the transfer.

10. The Enterprise shall not without the prior approval of the Minister carry on the activity for which it is registered in any location in Papua New Guinea other than Kieta.

11. In selling, leasing, granting licences or rights of entry in respect of or otherwise disposing of any real property or any interest in real property, the Enterprise shall not discriminate between persons on the basis of race, tribe, place of origin, political opinion, colour, creed, religion or sex.

12. Other than the two expatriate shareholders, only Papua New Guineans shall be employed by the Enterprise unless prior approval to do otherwise is granted to the Enterprise by the Secretary for Labour and Industry.

4. The Enterprise shall comply with all and any obligations and conditions relating to the employment of noncitizens, training of employees and the localisation of its staff (including both employees and officers of the Enterprise) which may from time to time be laid down by the Department of Labour, Commerce and Industry (or any other Department which succeeds to the functions of that Department) or prescribed or declared under the *Employment* (*Training and Regulation*) Act 1971 or under any other Act dealing with employment of non-citizens, training and localisation of employees.

5. Unless otherwise determined by the Minister, Papua New Guineans or local enterprises shall by the fifth anniversary of the date of registration and at all times thereafter own and control not less than 50% of the Enterprise.

6. Subject to the Act, the registration of the Enterprise is for five years from the date of registration but may be extended from time to time by the Minister on the application of the Enterprise.

7. If at the expiration of six months from the date of registration the Enterprise has not commenced carrying on business in any of the activities for which it is hereby registered, the registration of the Enterprise shall thereupon cease and determine in respect of those activities.

8. The Enterprise shall guide and assist Papua New Guinean enterprises in establishing business in ancillary activities.

9. The Enterprise shall not register any transfer of its shares until NIDA has been notified in writing of the transfer.

10. The Enterprise shall not without the prior approval of the Minister carry on the activity for which it is registered in any location in Papua New Guinea other than Section 5, Lot 14, Goroka, Eastern Highlands Province.

11. Other than the manager, only Papua New Guineans shall be employed by the Enterprise unless prior approval to do otherwise is granted to the Enterprise by the Secretary for Labour, Commerce and Industry.

5. Unless otherwise determined by the Minister, Papua New Guineans or local enterprises shall by the third anniversary of the date of registration and at all times thereafter own and control not less than 25% of the Enterprise.
