National Airline Commission Act 1973

APPOINTMENT OF MEMBERS OF THE NATIONAL AIRLINE COMMISSION

I, Tore Lokoloko, G.C.M.G., Governor-General, by virtue of the powers conferred by Sections 7 and 11 of the *National Airline Commission Act 1973* and all other powers me enabling, acting with, and in accordance with, the advice of the National Executive Council, hereby—

- (a) on the recommendation of the Minister for Transport, appoint each person specified in Column 1 of Schedule 1 to be a member of the National Airline Commission for the period specified in Column 2 opposite the name of that member; and
- (b) on the recommendation of the Company, appoint each person specified in Column 1 of Schedule 2 to be a member of that Commission for the period specified in Column 2 opposite the name of that member; and
- (c) by agreement with the Australian nominees and the Company, appoint Paul Pora to be Chairman of that Commission for 3 years,

to come into effect on and from the date of commencement of the *National Airline Commission (Amendment) Act 1978.*
