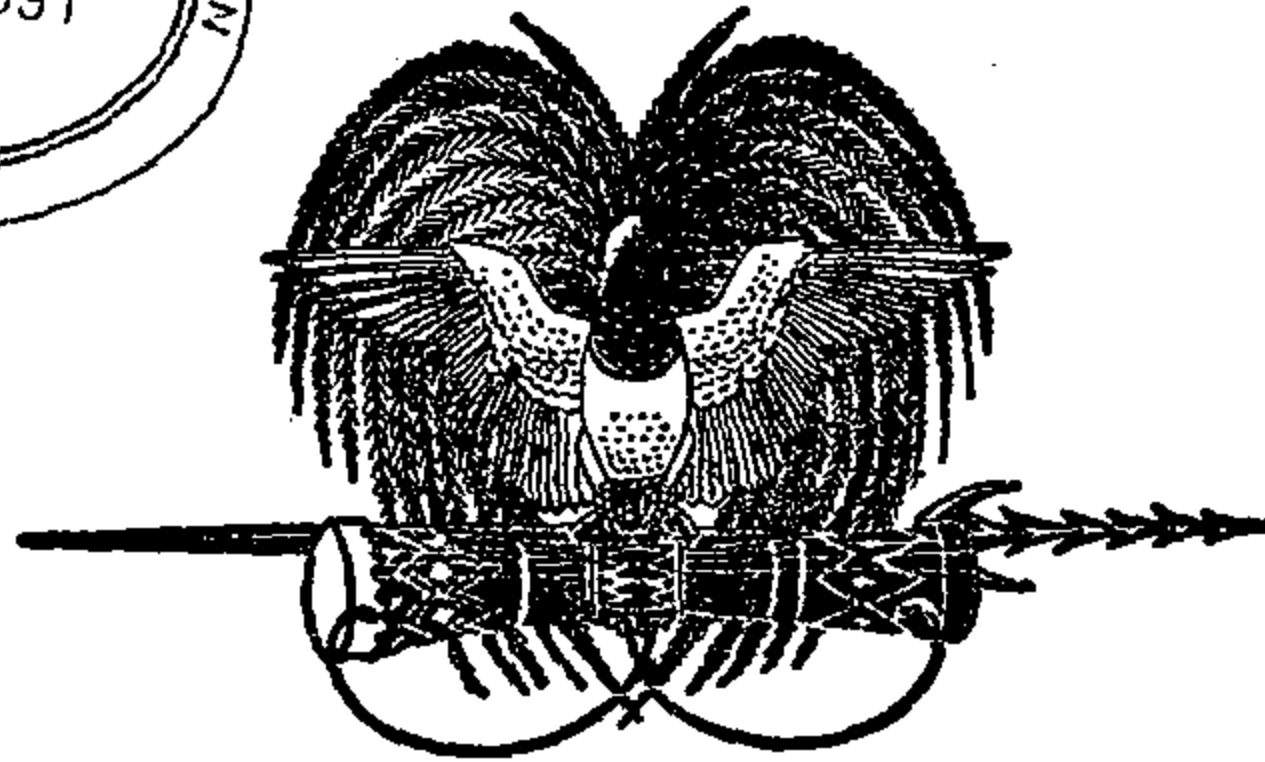

Customs Tariff Act 1990

REDUCED RATE OF IMPORT DUTY

I, Dennis Young, C.M.G., Acting Governor-General, by virtue of the powers conferred by Section 9(1)(b) of the *Customs Tariff Act 1990* and all other powers me enabling, acting with, and in accordance with, the advice of the National Executive Council, hereby Reduce the rate of import duty on the goods described in Column 2 of the Schedule to the rate shown in Column 3 opposite the description.

Customs Tariff Act 1990

EXEMPTION FROM IMPORT DUTY

I, Dennis Young, C.M.G., Acting Governor-General, by virtue of the powers conferred by Section 9(1)(a) of the *Customs Tariff Act 1990* and all other powers me enabling, acting with, and in accordance with, the advice of the National Executive Council, hereby Exempt from import duty the goods specified in the Schedule by tariff classification number and description.

SCHEDULE
