A Prices Order to amend the General Prices Order 1983.

MADE by the Price Controller under the *Prices Regulations Act* (Chapter 320) to come into operation on 1st January, 1992 for Public lighting charges and 1st April, 1992 for all other charges.

REPEAL AND REPLACEMENT OF SCHEDULE 10.
