## PROVISIONAL SUSPENSION OF GULF PROVINCIAL GOVERNMENT

THE NATIONAL EXECUTIVE COUNCIL, by virtue of the powers contained in Section 187E(1) of the Constitution and Section 91A of the Organic Law on Provincial Government having considered a report from the Minister and being of the opinion that a ground for suspension exists and that the matter can be only be put right by suspension, hereby provisionally suspends the Gulf Provincial Government with effect from 7.45 a.m. on 28th January, 1993.

## **REVOCATION OF APPOINTMENTS AND APPOINTMENTS UNDER SECTION 50**

I, Paias Wingti, Prime Minister, by virtue of the powers conferred by Section 50 of the Organic Law on Provincial Government and all other powers me enabling, on the recommendation of the Minister for Village Services and Provincial Affairs, (by virtue of this authority conferred on him by the National Executive Council under Section 98(2)(b) of the Organic Law on Provincial Government in respect of each Provincial Government under suspension or provisional suspension), made after consultation with the Public Services Commission, hereby—

(a) in relation to Morobe Province, revoke the appointment of Manasupe Zurenuoc to act and appoint Clant Kieta Alok in an acting capacity to act; and

(b) in relation to East Sepik Province, revoke the appointment of Vincent Maragau to act and appoint Henry Veratau in an acting capacity to act; and

(c) in relation to Milne Bay Province, revoke the appointment of Augustine Jonathan to act and appoint Ataia Andrew in an acting capacity to act; and

(d) in relation to Western Province, revoke the appointment of Tuwe Olewale to act and appoint Gerson Amen in an acting capacity to act; and

(e) in relation to Southern Highlands Province, revoke the appointment of Joseph Keviame to act and appoint Dominic Diya in an acting capacity to act; and

(f) in relation to Gulf Province, revoke all previous appointments to act and appoint Jacob Kairi in an acting capacity to act,

for the purposes of Section 50 of the Organic Law on Provincial Government with effect from the date of publication of this instrument in the National Gazette until further notice.
