PAGES 42—43—CLAUSE 50 (AMENDMENT OF SECTION 125)

Delete Paragraph (c) and substitute it with the following:—

- "(c) by repealing Subsection (5) and replacing it with the following:-
 - "(5) The Interim Provincial Governor shall, from amongst the members referred to in Subsection 1(a), (b) and (d), appoint the Interim Deputy Provincial Governor who shall also be the Interim Deputy Chairman of the Interim Provincial Assembly.".

PROPOSED AMENDMENTS TO CLAUSE 22 OF THE PROPOSED LAW TO ALTER THE ORGANIC LAW ON PROVINCIAL GOVERNMENTS AND LOCAL-LEVEL GOVERNMENTS.

THE Honourable, the Leader of Opposition, Roy Yaki, To move-

PAGES 25 - 26. CLAUSE 22 (NEW SECTION 33A).

Delete - Subclauses (3), (4) and (5) and replace them with the following:-

"(3) The Joint District Planning and Budget Priorities Committee shall have the following functions:-

- (a) to oversee, co-ordinate and make recommendations as to the overall district planning, including budget priorities, for consideration by the Provincial Government and the National Government; and
- (b) to determine and control the budget allocation priorities for the Local-level Governments in the district; and
- (c) to approve the Local-level Governments budgets for presentation to the Local-level Government and make recommendations concerning them; and
- (d) to draw up a rolling five year development plan and annual estimates for the district; and
- (e) to conduct annual reviews of the rolling five-year development plan; and
- (f) to manage and administer the district development grant specified under Subsection (4).
- "(4) In addition to any other grants under the Organic Law, the National Government shall, for each fiscal year, make an unconditional grant to each Joint District Planning and Budget Priorities Committee of an amount not less than K1,000,000.00 for the purposes of district development.
 - "(5) The grant specified in Subsection (4)-
 - (a) is guaranteed annually to each Joint District Planning and Budget Priorities Committee; and

- (b) shall be paid to the Provincial and District Treasury.
- "(6) The District Administrator shall be the Chief Executive Officer of the Committee.
- "(7) An Act of the Parliament shall make provision for other functions and powers of, and the administrative arrangements for, the Committee.".
