*Customs Tariff Act 1990*

## EXEMPTION FROM IMPORT DUTY

I, Silas Atopare, G.C.M.G., K.St.J., Governor-General, by virtue of the powers conferred by Section 9 (1)(a) of the *Customs Tariff Act 1990* and all other powers me enabling, acting with, and in accordance with, the advice of the National Executive Council, hereby exempt from payment of import duty the 16 vehicles mentioned in Schedule 1 imported between 1st September, 1998 and 20th September, 1998 and subject to such conditions as are specified in Schedule 2.

### SCHEDULE 1

3 x Mazda 929 Sedans  
 7 x Mazda 323 Sedans  
 2 x (4 x 4) Double Cab Utilities  
 2 x Toyota Land Cruisers  
 2 x 25 Seater Buses

### SCHEDULE 2

Motor Vehicles as mentioned in Schedule 1 imported between 1st September, 1998 and 20th September, 1998 by PNG Motors under an arrangement with the Government of Papua New Guinea and approved by the Commissioner-General for the purpose of on-lending on a gratuitous basis by the owners to and for the use by participants at the Hiri Moale Festival and Independence Celebrations in September, 1998 on condition that the motor vehicles shall, upon the conclusion of the Hiri Moale Festival and Independence Celebrations, be sold to Government Agencies at a price fully reflecting the reduction in import duty.

Should any motor vehicle subject to duty exemption herein be sold, exchanged, traded or otherwise disposed of before 12th September, 1998, the owner shall be liable for and import duty shall be payable at the date of such disposal on the CIF value of the motor vehicle at the date of original importation.

CONSTITUTION

*Organic Law on Provincial Governments and Local-level Governments*

**AUTHORIZATION OF MINISTER TO EXERCISE EXECUTIVE POWERS OF A SUSPENDED PROVINCIAL GOVERNMENT ON BEHALF OF THE NATIONAL EXECUTIVE COUNCIL**

THE NATIONAL EXECUTIVE COUNCIL, by virtue of the powers conferred by Section 187E(5) of the Constitution and Section 67(2)(b) of the *Organic Law on Provincial Governments and Local-level Governments*, hereby authorizes the Minister for Provincial and Local Government Affairs to exercise and perform, on behalf of the National Executive Council, all the executive powers, functions, duties and responsibilities of the provisionally suspended Northern Provincial Government.
