#### Customs Tariff Act 1990

#### REVOCATION OF EXEMPTION NOTICES

- I, Silas Atopare, G.C.M.G., K.St.J., Governor-General, by virtue of the powers conferred by Section 9(1) of the Customs Tariff Act 1990, and all other powers me enabling, acting with, and in accordance with the advice of the National Executive Council, hereby revoke all the existing exemptions published in the National Gazette (except notice published in the National Gazette G.49 dated 9th April, 1999) with effect on and from the date of publication of this instrument in the National Gazette, except for the following:—
  - (a) exemption from and reduction of import duties in respect of certain goods imported from the Republic of Fiji, published in *National Gazette* No. G117 of 8th October, 1998; and
  - (b) exemption published in National Gazette No. G35 of 8th April, 1998 in respect of items imported for-
    - (i) the Gazelle Restoration Programme until 31st December, 2000; and
    - (ii) the Bougainville Restoration Programme until 31st December, 2003; and
  - (c) exemptions published in National Gazette No. G80 of 2nd October, 1997 with respect to-
    - (i) Goods which are imported by a community organisation, certified by the Secretary of the Department of Prime Minister as an organisation that is not engaged in any commercial activity but exclusively devoted to the public interest and relating to—
      - (A) the advancement of education and vocation training; or
      - (B) the provision of medical services; and
    - (ii) Goods for educational or training purposes-
      - (A) to be used by the education institutions or training institutions officially recognised by the secretary for Education or the Commissioner for Higher Education; and

#### Revocation of Exemption Notices-Continued

- (B) not for sale, exchange or trade within 5 years; and
- (C) which are imported on a firm and specific order; and
- (D) which in the opinion of the Commissioner General cannot be locally produced or manufactured; and
- (E) certified by the Secretary for Education or the Commissioner for Higher Education to be necessary for the purposes of approved curriculum or of education or training institutions themselves; and
- (F) the Commissioner General is satisfied that the goods are solely required to be used by such educational or training institutions themselves; and
- (G) if such exempt goods be disposed of within 5 years from the date of import without prior written approval of the Commissioner General then duty apportioned in relation to the remaining unused period shall be payable; and
- (H) when purchased on the basis of duty free quotation/tender, the sale price shall not exceed 120% of the C.I.F. value and is supported by import documents; and
- (d) exemption in respect of goods imported from Solomon Islands or Vanuatu prescribed in the Schedule to *National Gazette* No. G108 of 23rd November, 1995.
