NOTICE OF PROHIBITION OF USING SHIPS FOR SEARCHING FOR OR TAKING SEDENTARY ORGANISMS

I, Galewa Kwarara, Chairman of the National Fisheries Board, by virtue of the powers conferred by Section 30(3)(d) of the Fisheries Management Act 1998 and all powers me enabling and upon recommendation of the Authority, hereby prohibit the use of ships for searching for or taking sedentary organisms as declared under Section 2(3) unless authorised by a Licence under the Fisheries Management Act 1998.

NOTICE OF PROHIBITION OF TAKING SEDENTARY ORGANISMS

- I, Galewa Kwarara, Chairman of the National Fisheries Board, by virtue of the powers conferred by Section 30(3)(d) of the Fisheries Management Act 1998 and all powers me enabling and upon the recommendation of the Authority, hereby prohibit—
 - (a) the taking of trochus shells (Trochus sp), Beche-de-mer (all species), Blacklip (Pinctada maragaritifera) Green Snail (Turbo mamoratus) Goldlip (Pinctada maxima) and reef fish by the use of scuba or hookah gear; and
 - (b) the taking of all sedentary organisms at night by the use of underwater and surface lights.
