Organic Law on Provincial Governments and Local-level Governments

## REVOCATION OF PROVINCIAL ADMINISTRATOR AND ACTING PROVINCIAL ADMINISTRATOR AND APPOINTMENT OF ACTING PROVINCIAL ADMINISTRATOR

THE NATIONAL EXECUTIVE COUNCIL, by virtue of the powers conferred by Section 73(2) of the Organic Law on Provincial Governments and Local-level Governments and all other powers it enabling, after considering a list comprising the names of three persons submitted by Minister for Public Service and after consultation with the Public Services Commission, hereby:—

(a) revoke the appointment of-

- (i) Albert Milala as Provincial Administrator of Gulf Province; and
- (ii) Miri Setae as Acting Provincial Administrator of Gulf Province: and
- (b) appoints Miai Larelake as Acting Provincial Administrator of Gulf Province,
