*Banks and Financial Institutions Act 2000***CREDIT CORPORATION FINANCE LIMITED**

THE BANK OF PAPUA NEW GUINEA, acting under Section(1)(b) of the *Banks and Financial Institutions Act 2000* and all other powers enabling it, vary the condition of Credit Corporation (PNG) Limited (CCPNG) to conduct business as a licensed financial institution through a wholly subsidiary to be called Credit Corporation Finance (CCF) to enable timely and simplify reporting to BPNG and issues herewith a Notice Imposing Conditions on its licence:

CONDITION

- (1) The license holder will accept deposits only from corporate, government, statutory authorities and deposits from individuals exceeding K5,000.00.
- (2) No foreign currency dealer status will be granted to the license holder.
- (3) The licence holder will only undertake banking business and will ensure that its Constitution will at all times restrict business only to banking business. If it wishes to carry on any other business, it shall require written approval of the Bank of Papua New Guinea.
- (4) The Credit Corporation Finance (CCF) Limited will obtain from Credit Corporation (PNG) (CCPNG) Limited an irrevocable and unconditional Letter of Commitment or Guarantee that CCPNG undertakes to inject capital funds to discharge CCF's obligations and commitments to depositor's, investors or creditors promptly if and when Bank of PNG directs. A copy of the undertaking will be provided to the Central Bank by CCF.
