CONSTITUTION

AMENDMENT OF DETERMINATION OF TITLES AND RESPONSIBILITIES OF MINISTERS

I, Samuel T. Abal, Acting Prime Minister, by virtue of the powers conferred by Section 148 of the Constitution and all other powers me enabling, hereby amend the Determination of Titles and Responsibilities of Ministers published in *National Gazette* No. G57 dated on 3rd March, 2011 (as amended):—

- (a) in Schedule 2 (Deputy Prime Minister and Minister for Works)—
- (i) by deleting words “and Minister for Works” whenever the words appear and substituting “and Minister for Immigration and Citizenship”; and
 - (ii) in Column 3 by deleting Paragraphs (a), (b), (c) and (d) and substituting the following:
 - “(a) Immigration and Citizenship matters”; and
 - “(b) Passport matters”; and
 - (iii) in Column 4 by deleting the following:
 - Architects’ Registration Act 1989*
 - Building Act (Chapter 301)*
 - Dumping of Wastes at Sea Act (Chapter 369) (except ss. 6 and 7)*
 - Professional Engineers (Registration) Act 1986*
 - Roads Maintenance Act (Chapter 246)*
 - Submarine Cables and Pipelines Protection (Adopted) Act (Chapter 247); and*
 - (iv) in Column 4 by inserting the following:
 - “(a) *Immigration Act (Chapter 16)*”; and
 - “(b) *Passport Act (Chapter 17)*”; and
 - “(c) *Immigration and Citizenship Service Authority Act 2010*”; and

- (b) in Schedule 18 (Minister for Foreign Affairs, Trade and Immigration)—
- (i) in Column 2 by deleting the words “and Immigration”; and
 - (ii) in Column 3 by deleting in Paragraph (e); and
 - (iii) in Column 4 by repealing the following:
 - “*Immigration Act* (Chapter 16)”; and
 - “*Passport Act* (Chapter 17)”; and
- (c) in Schedule 30 (Minister for State and Minister Assisting the Prime Minister) in Column 1 by deleting “Patrick Pruaitch”.
- (d) in Schedule 31 (Minister for Administrative Services and Minister Assisting the Prime Minister on Constitutional Matters)—
- (i) in Column 2—
 - (A) by deleting the words “Minister for Administrative Services and”; and
 - (B) by deleting the words “Constitutional matters”, and substituting “*Organic Law on National and Local-level Government Elections*”; and
 - (ii) by deleting from the Schedule the words “Minister for Administrative Services and”; and
 - (iii) by repealing Column 4 and substituting the following:
 - “in Column 4—
 - Organic Law on National and Local-level Government Elections*”; and
 - (iv) in Column 3 by repealing Paragraph (a) and (b), and substituting the following:—
 - “*Organic Law on National and Local-level Government Elections*”.
