# EXEMPTION FROM IMPORT DUTY, GOODS AND SERVICES TAX ON MATERIALS FOR THE 2012 GENERAL ELECTION PREPARATION

I, SIR MICHAEL OGIO, G.C.M.G., K. St. J., Governor-General, by virtue of the powers conferred by Section 9(1)(a) of the Customs Tariff Act 1990 and Section 25(8) of the Goods and Services Tax Act 2003, and all other powers me enabling, acting with, and in accordance with, the advice of the National Executive Council, hereby exempt from import duty, the list of materials and equipment referred to in the Schedule in relation to the 2012 General Election related preparations commencing on and from 1st April, 2012 to 31st July, 2012.
