Employment of Non-citizens Act 2007

NOTICE OF EXEMPTION

I, Martin Aini (MP)., Minister for Labour and Industrial Relations in exercise of the powers conferred to me under Section 51(1) of the *Employment of Non-citizens Act* 2007 do hereby exempt the following non-citizens employees of Daewoo Engineering & Construction Ltd listed below from the requirement to hold a work permit and Sections 12 & 13 of the said Act.

In accordance with the requirement of Section 51(3) of the Act, I hereby grant approval of these exemptions to the abovementioned non-citizens in the interest of the nation and for a good cause, particularly in view of the LNG project's significant contribution to the economic, human resource and infrastructure developments in Papua New Guinea.

Specific conditions placed against the exemptions are:—

- (1) For the company to pay a fee of K2,000.00 for each employee to the Department of Labour & Industrial Relations;
- (2) For the company to provide employment opportunities (decent work, fair pay, promotions etc) to citizen workers;
- (3) For the company to provide opportunities for human resource development and skills training to its employees.

- (2) For the company to register all non-citizen employees that require registration with a professional body;
- (3) For the company to provide employment opportunities (decent work, fair pay, promotions etc) to citizen workers;
- (4) For the company to provide opportunities for human resource development and skills training to its employees; and
- (5) Non English speaking countries to show evidence of English proficiency for applicants.
