Public Services (Management) Act 1995

REVOCATION OF APPOINTMENT AND APPOINTMENT OF DEPARTMENTAL HEAD

I, Sir Michael Ogio, G.C.M.G., K.St.J., Governor-General, by virtue of the powers conferred by Section 193(31A) and (1B) of the Constitution and all other powers me enabling, acting with, and in accordance with, the advice of the National Executive Council and in accordance with a recommendation by the Public Services Commission following the procedures prescribed by Section 31A and 31B of the *Public Services (Management) Act* 1995, hereby:—

- (a) revoke the appointment of Russel Ikosi as Acting Secretary for the Department of Provincial and Local-level Government Affairs as published in the *National Gazette* No. G250 of 11th of August, 2011; and
- (b) appoint Munare Uyassi as Secretary for the Department of Provincial and Local-level Government Affairs for a period of four (4) years,
