REVOCATION OF APPOINTMENT OF ADMINISTRATOR AND APPOINTMENT OF ACTING ADMINISTRATOR OF PROVINCIAL ADMINISTRATOR

THE NATIONAL EXECUTIVE COUNCIL, by virtue of the powers conferred by:—

- (a) Section 73(2B) of the *Organic Law on Provincial Governments and Local-level Governments* and Section 60B of the *Public Services (Management) Act 1995* and all other powers it enabling, hereby revoke the appointment of Simeon Malai as Provincial Administrator for New Ireland Province; and
- (b) Section 73(2A) of the *Organic Law on Provincial Governments and Local-level Governments* and Section 60A of the *Public Services (Management) Act 1995*, and all other powers it enabling, after considering a list comprising the names of three persons submitted by the Minister for Public Service after consultation with the Public Services Commission, hereby appoint Monovi Amani as Acting Provincial Administrator for New Ireland Province for a period of three months or until a substantive appointment is made, whichever occurs first,

with effect on and from 15th February, 2012.

REVOCATION OF ACTING APPOINTMENT AND APPOINTMENT OF ACTING PROVINCIAL ADMINISTRATOR

THE NATIONAL EXECUTIVE COUNCIL, by virtue of the powers conferred by Section 73(2A) of the *Organic Law on Provincial Governments and Local-level Governments* and Section 60A of the *Public Services (Management) Act 1995*, and all other powers it enabling, in accordance with a recommendation from the Southern Highlands Provincial Executive Council, and in accordance with a recommendation from the Public Services Commission, following procedures prescribed by or under the *Public Services (Management) Act 1995*, hereby—

Revocation of Acting Appointment and Appointment of Acting Provincial Administrator—*continued*

- (a) revoke the appointment of William Powi as Acting Provincial Administrator of Southern Highlands Province; and
- (b) appoint Ugia Kembo to be the Acting Provincial Administrator of Southern Highlands Province until a permanent appointment is made which ever occurs first,
with effect on and from 15th May, 2012.
