## Employment of Non-Citizens Act 2007

### EXEMPTION NOTICE

I, Mark Maipakai, MP., Minister for Labour and Industrial Relations in exercise of the powers conferred on me under Section 51(1) of the *Employment of Non-citizens Act 2007*, do hereby exempt and grant extension of work permit exemptions for the following seven (7) non-citizen employees of Consolidated Contractors (PNG) Company Limited and one (1) non-citizen employee of McConnell Dowellconst (Png) Pty ltd listed below from Sections, 12 and 13 of the said Act.

The Department of Labour and Industrial Relations is satisfied with the training and up skilling opportunities provided to its citizen employees and the employment opportunities given to citizens as set as conditions in Gazettal Notice No; G468- issued 3rd December, 2012 and 2012 Gazettal Notice No: G318- issued 11th November, 2011.

These exemptions are given to the abovementioned non-citizens in their period of employment to work in country without a work permit for six (6) months beginning 12 August 2013, 6 September 2013 and 31 October 2013 to 31 January 2014.

In accordance with the requirement of Section 51 (3) of the Act I hereby grant approval of these exemptions to the abovementioned non-citizens in the interest of the nation and for a good cause, particularly in view of the LNG project's significant contribution to the economic, human resource and infrastructure developments in Papua New Guinea.

*Specific conditions placed against the exemptions are:-*

1. The companies to pay a fee of K4,000.00 for the 7 non-citizen employees of Consolidated Contractors (PNG) Company Limited and 1 non-citizen employee of McConnell Dowellconst. (png) Pty Ltd.
2. For the company to provide employment opportunities to citizens,
3. For the company to provide opportunities for human resource development and skills training to its employees,
4. For the company to register all non-citizen employees that require registration with a professional body,
5. Non English speaking countries to show evidence of English proficiency for applicants,
6. The company to have this gazettal notice easily available at the time of work permits inspection.
7. The company to revoke this gazettal notice at the completion of this assignment by providing evidence of repatriation to the Department.
