The exemptions are granted from Thursday, 29th May, 2014 and effective for an indefinite period.

Specific conditions placed against the exemptions are:-

1. For the organization to provide opportunities for human resource development and skills training to its employees.
2. To have this Gazettal Notice readily available at all times, and be produced upon demand to an Authorized work Permit Inspector upon request.
