Public Services (Management) Act 1995

REVOCATION OF ACTING APPOINTMENT AND APPOINTMENT OF PROVINCIAL ADMINISTRATOR FOR MILNE BAY PROVINCE

THE NATIONAL EXECUTIVE COUNCIL, by virtue of the powers conferred by —

- (a) Section 73(2A) of the *Organic Law on Provincial Governments and Local-level Governments* and Section 60A of the *Public Services (Management) Act 1995* and all other powers it enabling, in accordance with a recommendation from the Milne Bay Provincial Executive Council, and in accordance with a recommendation from the Public Services Commission following procedures prescribed by or under the *Public Services (Management) Act 1995*, hereby revoke the appointment of Michael Kape as Acting Provincial Administrator of Milne Bay Province; and
- (b) Section 73 (2B) of the *Organic Law on Provincial Governments and Local-level Governments*, and Section 60B of the *Public Services (Management) Act 1995*, and all other powers it enabling, with a recommendation from the Milne Bay Provincial Executive Council, and in accordance with a recommendation from the Public Services Commission, following procedures prescribed by or under the *Public Services (Management) Act 1995*, hereby appoint Michael Kape as Provincial Administrator of Milne Bay Province, for a period of four (4) years,

commencing on and from 25th September, 2014.
