AMENDMENT OF DETERMINATION OF TITLES AND RESPONSIBILITIES OF MINISTERS

I, **PETER O'NEILL**, Prime Minister, by virtue of the powers conferred by Section 148 of the **Constitution** and all other powers me enabling, hereby amend the Determination of Titles and Responsibilities of Ministers dated 10th August, 2012 and published in the *National Gazette* No. G304 of 10th August, 2012 (as amended) —

- (a) in Schedule 6 (**Minister for Transport and Infrastructure**), in Column 1, by deleting “**Nixon Duban**” and inserting “**Malakai Tabar**”; and
- (b) in Schedule 12 (**Minister for Higher Education, Research, Science and Technology**), in Column 1, by deleting “**Malakai Tabar**” and inserting “**Francis Marus**”; and
- (c) in Schedule 17 (**Minister for Petroleum and Energy**), in Column 1, by deleting “**Ben Micah**” and inserting “**Nixon Duban**”.
