THE CUSTOMS EXCISE ACT
(CAP. 58)CUSTOMS AND EXCISE (DUTIES) (AMENDMENT)
(NO. 7) ORDER 1998

IN exercise of the powers conferred by section 7 of the Customs and Excise Act, I, BARTHOLOMEW ULUFA'ALU, Acting Minister of Finance, do hereby make the following Order:-

1. This Order may be cited as the Customs and Excise (Duties) (Amendment) (No. 7) Order 1998 and shall come into force on the date of publication in the Gazette.

2. That part of the First Schedule to the Customs and Excise Act entitled, "EXPORT CLASSIFICATION AND TARIFF" is hereby amended as follows:-

By deleting headings, "item numbers", "commodities", "units of quantity" and "rates of the export duty", appearing after 44.03 and before 4407.0010 and by inserting the following headings, "item numbers", "commodities", "units of quantity" and "rates of export duty" as follows:-

3. That part of the First Schedule to the Customs and Excise Act, entitled "EXPORT SCHEDULE NOTES", is hereby amended by deleting Note 1 and inserting the following Note:-

1. The Comptroller shall from time to time, determine the value for duty for export of round logs, based upon advice from the Commissioner of Forests, and shall publish the determined values in the Gazette. The determined values will have effect from the date of publication until further amendment;

4. That Part of the First Schedule to Customs and Excise Act, entitled "EXPORT CLASSIFICATION AND TARIFF" is hereby amended by inserting between item no. 2604.0000 and 2616.0000 the following:-
