BY-ELECTION ORDER**

IN exercise of the powers conferred by section 13 of the Provincial Government Act, 1997 as read together with regulation 9 of the Provincial Assemblies Election Regulations, 1986, I, JAPHET WAIPORA, Minister of Provincial Government and Rural Development, do hereby -

- (i) appoint 20th December 1999 for the holding of the bye-election of the member of the Temotu Provincial Assembly for Ward 9;
- (ii) appoint MR. ANDREW NANAUOHA to be the Returning Officer; and
- (iii) require nominations in respect of persons submitting themselves for the bye-election for the Graciosa Bay Ward to be submitted to the Returning Officer not later than 4 o'clock in the afternoon of 21st November 1999, at the Provincial Headquarters, Lata.
