# THE PORTS (DECLARATION OF PORT LIMITS) (PORT OF TETERE) ORDER 1997

IN exercise of the powers conferred by section 5 of the Ports Act. I. DANNY PHILIP, Minister of Commerce, Industries and Employment, do hereby make the following order

This Order may be cited as the Ports (Declaration 1. of Port Limits) (Port of Tetere) Order 1997.

The limits of the Port of Tetere are declared to be as  $\widehat{\phantom{a}}$ specified in the Schedule.

#### SCHEDULE

LR1014 is located in the Ghaobata Ward, Bolomona Council Area on Guadalcanal Island in Solomon Islands and located in the Tetere area and described herein

The described area includes the water from the high water mark (HWM) and below the HWM and is located on the survey plants XK3358 and XK32/56.

All that are commencing at the southwest corner at an unpegged coordinated point HW1 and at grid bearing 360 degrees for a distance of 571.0 metres to an unpegged coordinated point RM10, thence 90 degrees 25 minutes 50 seconds for a distance of 452.07 metres to an impegged coordinated point RM20, thence 180 degrees for a distance of 583.0 metres to an unpegged coordinated point HW4. thence along the HWM in the westerly direction to the point of origin HW1

The area contained within the above described area to an 193 hectares."
