### THE SAFETY AT WORK ACT 1982 (NO. 3 OF 1982)

# THE SAFETY AT WORK (FEES FOR TESTS OR EXAMINATION) (AMENDMENT) REGULATIONS 1998

IN exercise of the powers conferred by section 25 of the Safety at Work Act, 1982, the Minister hereby makes the following regulations -

- 1. These Regulations may be cited as the Safety at Work (Fees for Tests or Examinations) (Amendment) Regulations 1998
- 2. The Safety at Work (Fees for Tests or Examinations) Regulations 1982\* is hereby amended by deleting section 2 thereof and substituting therefore the following -
  - 2. The fees payable for a test or examination of a pressure system or lifting machine or a lifting tackle conducted by a competent person under the provisions of section 17, or section 18 of the Act, as the case may be, shall comprise the following amounts in the Schedule, that is to say -

"Payment of fees for tests or examination conducted by competent persons
