### THE ELECTRICITY (TARIFF) (AMENDMENT) BY-LAWS 1998

IN exercise of the powers conferred by sections 22 and 56(2) of the Electricity Act, the Minister, on the recommendation of the Authority, hereby makes the following By-Laws -

- 1. These By-Laws may be cited as the Electricity (Tariff) (Amendment) By-Laws 1998, and shall come into force on the date of publication in the gazette.

General and all other Tariff (i.e. Industrial,

61.0 cents

Commercial, Government) for each Kilowatt hour

Service charge (above 23 Kilowatt hour) or Minimum monthly charge (below 23 Kilowatt Hour) \$5.00".

### THE ELECTRICITY (HIGH VOLTAGE) (TARIFF) (NORO) ORDER 1998
