(Cap. 60)

THE IMMIGRATION (FEES AND FORMS) (AMENDMENT) REGULATIONS 1999

IN exercise of the powers conferred by section 19 of the Immigration Act, the Minister hereby makes the following Regulations -

- 1. These Regulations may be cited as the Immigration (Fees and Forms) (Amendment) Regulations 1999.
- 2. The Second Schedule to the Immigration (Fees and Forms) Regulations is hereby amended by adding at the end thereof, the following:-

Cap 60 Sub Leg p. 1904

"On clearance in respect of each \$200.00 international flight landing on or departing from an airport in Solomon Islands

On clearance in respect of ships entering or departing from any port in Solomon Islands

\$200.00

On clearance in respect of yachts or other pleasure craft entering or departing from any port in Solomon Islands \$100.00"

THE PRISONS ACT

(Cap. 111)

THE PRISONS (INJURIES AND DEATH BENEFIT) REGULATIONS 1999.

IN exercise of the powers conferred by section 61 of the Prisons Act, the Prime Minister hereby makes the following Regulations

- 1. These Regulations may be cited as Prisons (Injuries and Death Benefit) Regulations, 1999.
- 2. Where any prison officer suffers injury in the course of duty, the Government shall be liable to pay such prison officer compensation in accordance with the provisions of the Schedule.
- 3. Where any prison officer suffers injury in the course of duty which results in the death of such prison officer, the Government shall be liable to pay the dependants of such deceased prison officer compensation in accordance with the provisions of the Schedule.
 - 4. In these Regulations -

"injury" means injury which results in partial or total incapacity of a permanent nature.
