THE PASSPORT (VISA) REGULATIONS 1998

IN exercise of the powers conferred by section 19 of the Passport Act, 1978, I, DANIEL ENELE KWANAIRARA, Minister of Commerce, Employment and Tourism, do hereby make the following regulations -

1. These regulations may be cited as the Passport (Visa) Citation. Regulations 1998.

2. (1) Each application for a visa to enter Solomon Application for Islands other than for a transit visa, shall be made to a Passport Officer or a person designated by a Passport officer in Form 1 as prescribed in the First Schedule.

(2) The form shall be lodged with the Passport Officer together with -

(a) travel tickets of onward travel or satisfact ory evidence of onward travel arrangements;

(b) the applicant's passport or a certified copy thereof;

(c) the appropriate application fee;

(d) evidence of adequate financial means;

(e) two recent passport size photographs of the applicant; and

(f) other requirements as may be required by the Passport officer.

Interview by officer. 3. The Passport Officer may where he considers necessary require the applicant to appear before him for an interview.

Issuance of 4. Where the Passport Officer is satisfied that - visa.

(a) there is no reasonable ground to refuse the application; and

(b) the applicant is qualified to be issued a permit under the Immigration Act,

he shall issue to the applicant a visa by making an entry, as prescribed in form 2 in the First Schedule, on the passport, certificate or other valid travel documents of the applicant or where it is not reasonable practicable to make such entry, the passport officer may communicate by letter to the applicant that he will be issued a visa at such place as is mentioned in his letter.

within such period during the currency of the applicant's passport, travel documents or during the period of intended stay in Solomon Islands or for such period as the Passport Officer may deem appropriate.

(2) The expiry of a passport or a travel document of a person issued with a visa shall not render that visa issued under these Regulations invalid.

Transit visa.

6. A person who has a valid passport, certificate or other valid travel documents and transiting through Solomon Islands to another country may be issued with a transit visa in the form as prescribed in Form 2 in the First Schedule:

Provided that a person who possesses a transit visa shall not remain in Solomon Islands for a period exceeding seven days for which the transit visa was issued.

(2) A person intending to transit through Solomon Islands for a period not exceeding eight hours need not apply for a transit visa.

7. The following persons are exempt from the requirements of these Regulations -

.

Persons exempted.

(a) holders of Diplomatic Passports;

(b) officials of Foreign Government who are visiting Solomon Islands in the performance of their official duties;

(c) persons who are employed by the Solomon Islands Government; and

(d) any person to whom immunities and privileges have been extended in Solomon Islands under the Diplomatic Privileges and Immunities Act or any other Act and the family of such person.

8. Fees charged under these Regulations shall be as provided in the Second Schedule.


