THE CUSTOMS AND EXCISE (DUTIES) (AMENDMENT) (NO. 3 ORDER 1999)

IN exercise of the powers conferred by section 7 of the Customs and Excise Act, I, BARTHOLOMEW ULUFA"ALU, Acting Minister of Finance, do hereby make the following Order:

- 1. This Order may be cited as the Customs and Excise (Duties) (Amendment) (No. 3) 1999 and shall come into force on the date of publication in the Gazette;
- 2. That part of First Schedule to the Customs and Excise Act entitle "EXEMPTIONS SCHEDULE" is hereby amended by deleting from the schedule the words appearing under the "PARTIAL EXEMPTION FROM CUSTOMS DUTY" and substituting therefor the following -

"RAW MATERIALS FOR PROCESSING OR MANU FACTURING OPERATIONS, WHICH INVOLVE A CHANGE OF CHARACTER, SHALL BE EXEMPTED FROM DUTY NORMALLY CHARGEABLE UNDER THE TARIFF RATES IN EXCESS OF FIVE PERCENTUM.

GOODS, LISTED IN COLUMN 2 OF THE TABLE HEREUNDER, BEING GOODS THAT ARE CLASSIFIED WITHIN THE TARIFF HEADING LISTED IN COLUMN 1 OF THAT TABLE OPPOSITE THOSE GOODS, IMPORTED IN BULK FOR REPACKING FOR RETAIL SALE, SHALL BE EXEMPTED FROM DUTY NORMALLY CHARGE ABLE UNDER THE TARIFF RATES IN EXCESS OF FIVE PERCENTUM. THIS PROVISION DOES

NOT COVER GOODS IMPORTED IN WHATEVER SIZE PACKAGES OR CONTAINERS CAPABLE OF RETAIL SALE.

PROVENCIAL GOVERNMENT ACT 1997

WESTERN PROVINCE BUSINESS LICENCE (AMENDMENT) ORDINANCE 1998

AN ORDINANCE to amend the Western Province Business Licence Ordinance 1995.

1. This Ordinance shall be cited as the Western Province Business Licence (Amendment) Ordinance 1998 and shall come into force upon approval by the Minister pursuant to Section 30 of the Provincial Government Act 1997.

Title and Commencement

2. (a) The Western Province Business Licence Ordinance 1995, is hereby amended by inserting in section 2 in the appropriate alphabetic order the following definitions:

Amendments To S. 2 of No. 60/95

- ""Beautician" means the business of providing beautifying and/or remedial treatments for the face or body."
- ""Bus/Taxi Service" means the business of providing transportation services by any road vehicle or boat for paying passengers".
- ""Consultancy Service" means the business of providing services as an expert adviser to and/ or the business of drawing or preparing designs, drawings, plans, diagrams, maps or charts for, any individual, trade, profession or business".
- ""Engineering Service" means the business of making any machinery or installing, maintaining or repairing any machine, vehicle or outboard motor but does not include ship repairing".

- ""Financial Schemes" means the business of receiving monies for the purposes of investment thereof and/or the payment of returns thereon".
- ""Hawking" means the business of carrying goods for sale barter or exchange and includes the sale of foods, fish or other goods or products by any person at a place where that person does not usually reside or carry on business but does not include wholesaling".
- ""Recreational Fishing" means the business of taking paying customers for the purposes of game and/or sport fishing being non-commercial fishing".
- (b) Section 2 of the Western Province Business Licence Ordinance 1995, is hereby further amended by:
 - (i) deleting the definition "Electrical Service" and substituting therefor the following:
 - ""Electrical Service" means the business of building, installing, repairing, maintaining or removing of any electrical plant, fittings or apparatus or electronic device including but not limited to radios, videos, televisions, computers, word processors, typewriters, tape cassette recorders or photocopiers, but does not include the services performed by Solomon Island Electricity Authority".
 - (ii) deleting the definition "Sea Transport Service" and substituting therefor the following:
 - ""Sea Transport Service" means the business of providing transportation Services".
 - (iii) deleting the definition "Drafting".
 - (iv) deleting the definition "Hardware".
 - (v) deleting the definition "Used Clothing".

(c) Section 2 of the Western Province Business Licence Ordinance is hereby further amended by the insertion of the words" and/or products" between the word "goods" and "of" where they occur within the definition of "Exporting".
