THE CUSTOMS AND EXCISE ACT (CAP. 121)

THE CUSTOMS AND EXCISE (DUTIES) (AMENDMENT) (NO. 4) ORDER 1999

IN exercise of the powers conferred by section 7 of the Customs and Excise Act, I, ALPHA KIMATA, Minister of Finance, do hereby make the following order:-

- 1. This Order may be cited as the Customs and Excise (Duties) (Amendment) (No. 4) Order 1999 and shall come into force on the date of publication in the Gazette.
- 2. That Part of the First Schedule to the Customs and Excise Act appearing in the duty rate column as "\$3.60 per litre" against tariff classification 2201.0000 is hereby amended by deleting from the duty rate culumn "\$3.60 per litre" and inserting "40%".
- 3. Those Parts of the First Schedule to the Customs and Excise Act appearing in the duty rate column as "\$20.00 each" against tariff classifications 8524.2120, 8524.2220 and 8524.2320 are hereby amended by deleting from the duty rate column "\$20.00 each" and inserting "\$20.00 each or 40%, whichever the lower".
- 4. Those Parts of the First Schedule to the Customs and Excise Act appearing in the duty rate column as "70%" against the tariff classifications listed in the Table here under, are hereby amended by deleting from the duty rate column "70%" and inserting "40%".

THE PETROLEUM (AMENDMENT) RULE 1999

IN exercise of the powers conferred by section 10 of the Petroleum Act, the Minister hereby makes the following rule -

1. This Rule may be cited as the Petroleum (Amendment) Rule 1999.

2. Rule 38 of the Petroleum Rules is hereby amended in the following manner -

(a) in paragraph (b) of subrule (4), by deleting the words "of Works and Public Utilities" and substituting therefor the words "responsible for energy"; and

(b) deleting subrule (5) and substituting therefor the following new subrule (5) -

" (5) The fees for a licence shall be as follows -

more than 20,000 litres and not more than 40,000 litres\$1,000.00more than 40,000 litres and not more than 60,000 litres\$1,625.00more than 60,000 litres and not more than 80,000 litres\$2,250.00more than 80,000 litres and not more than 100,000 litres\$2,875.00more than 100,000 litres and not more than 120,000 litres\$3,500.00more than 120,000 litres and not more than 140,000 litres\$4,120.00more than 140,000 litres and not more than 160,000 litres\$4,750.00more than 160,000 litres and not more than 180,000 litres\$5,373.00more than 180,000 litres and not more than 200,000 litres\$6,000.00

3. The principal Rules* are hereby amended by deleting the Schedule thereto and substituting therefor the following new Schedule -

"SCHEDULE

The Petroleum Rules

Licence to Possess Petroleum

(Rule 38)

NO.

Licence is hereby granted to for the storage in the premises described below, of litres petroleum, subject tot he condition prescribed by the Petroleum Rules.

The Licence shall be valid for a period of twelve calendar month from the date hereof and may be renewed on application being made for this purpose not less than fifteen days previous to the date of expiry.

Date of issue Licensing Officer

This licence is issued subject to the provision of the Petroleum Rules of which the holder admits cognisance.
