THE CUSTOMS AND EXCISE (DUTIES)(AMENDMENT) (NO. 11) ORDER 1999

In exercise of the powers conferred by section 7 of the Customs and Excise Act, I, Alpha Kimata, Minister of Finance, do hereby make the following Order -

- 1. This Order may be cited as the Customs and Excise (Duties) (Amendment) (No. 11) Order 1999 and shall come into force on the date of publication in the Gazette.
- 2. The following goods falling within the terms of the headings and descriptions -
