THE IMMIGRATION ACT
(Cap. 60)

THE IMMIGRATION (MEDICAL STUDENTS ENTRY PERMITS)
(EXEMPTION) ORDER 2003

IN exercise of the powers conferred by section 7(g) of the Immigration Act, the Minister hereby makes the following orders -

1. This Order may be cited as the Immigration (Medical Student Entry Permits) (Exemption) Order 2003.
2. The following classes of persons may enter Solomon Island without a permit, that is to say -
 - (a) students undertaking medical studies in any overseas university or medical institutions entering Solomon Islands to undertake attachment or training in any hospital or medical institution in Solomon Islands as part of their training towards the fulfilment of the requirements of their medical qualification or as a prerequisite in the completion of their medical studies.
 - (b) volunteer medical officers who having recently completed their medical training and having attained their medical qualification enter Solomon Islands to undertake voluntary medical services in any hospital or medical Institution in Solomon Islands for purposes of attaining practical experience.
 - (c) any child or spouse or dependant of any person under (b) above provided such child, spouse or dependant shall apply for and be issued a student permit or a work permit prior to undergoing education or engaging in any employment in Solomon Islands during the period of his stay in Solomon Islands.
3. Every person qualifying under paragraph 2 shall furnish to the Director of Immigration all personal particular listed hereunder -

- (a) Full name
- (b) Nationality as given in Passport
- (c) Overseas address
- (d) Name and address of University or medical institution person is attending or has last attended including confirmation from such university or medical institution that the person is their student in the case of a medical elective student.
- (e) Name and address of hospital or medical institution to which the student or volunteer medical officer will carry out his or her elective or will work including approval granted by such hospital or medical institution.
