THE PRICE CONTROL (APPLICATION TO GOODS AND RESTRICTION OF PRICES) (AMENDMENT) ORDER 2003

IN exercise of the powers conferred by sections 4 and 6 of the Price Control Act, and after consultations with the Prices Advisory Committee, I, TREVOR OLAVAE, Minister of Commerce, Employment and Trade, do hereby make the following Order -

- 1. This Order may be cited as the Price Control (Application to Goods and Restriction of Prices) (Amendment) Order 2003 and shall come into operation on the 14th January 2003.
- 2. Schedule 3 to the Price Control (Application to Goods and Restriction of Prices) Order 1987* is hereby amended by deleting serial No.13 thereof and substituting therefor the following -

THE IMMIGRATION ACT (Cap. 60)

THE IMMIGRATION (FEES AND FORMS) (AMENDMENT) REGULATIONS 2003

IN exercise of the powers conferred by Section 19 of the Immigration Act, the Minister hereby makes the following regulations -

- 1. These Regulations may be cited as the Immigration (Fees and Forms) (Amendment) Regulations 2003, and shall come into operation on the date of publication in the gazette.
- 2. The Immigration (Fees and Forms) Regulations are hereby amended by -
 - (a) inserting immediately after regulation 13 therein the following new regulation as regulation 14 -
 - "14. (1) There shall be payable by the owner, master or agent of the vessel, aircraft or yacht concerned in respect of the boarding of, clearance of or attendance on such vessel, aircraft or yachts or other pleasure crafts by an Immigration Officer during official hours or after hours such sum as is specified in the Second Schedule hereto.
 - (2) The claims of working after official hours by an Immigration Officer shall be payable out of the sums paid pursuant to sub regulation (1).

- (3) The after hour or overtime claim by an Immigration Officer from the sum payable by the owner, master or gent of the vessel, aircraft or yacht or other pleasure craft shall be that payable to such officers of the same level as is applicable under current Public Service rules, regulations or General Orders for weekdays, Saturdays, Sundays and public holidays.
- (4) In any proceeding for the recovery of such sums as are due under sub regulation (1), a form or document signed by the Immigration Officer conducting the boarding or in attendance shall be prima facie evidence on such boarding and attendance and of the amount due by any person or body named therein."
