# THE DESIGNATION OF FOREIGN COUNTRY AND ADOPTION IN SOLOMON ISLANDS OF THE UNITED KINGDOM AIR NAVIGATION (OVERSEAS TERRITORIES) ORDER

IN exercise of the powers conferred upon the Minister by section 7A of the Civil Aviation Act (as amended by Act No. 13 of 1999), the Minister after consultation with the Aviation Operators in Solomon Islands hereby makes the following order -

- 1. This Order may be cited as the Designation of Foreign Country and Adoption in Solomon Islands of the United Kingdom Air Navigation Air Navigation (Overseas Territories) Order.
- 2. The United Kingdom is hereby designated as the Foreign Country for the purposes of this Order.
- 3. The United Kingdom Air Navigation (Overseas Territories) Order 2001 is hereby adopted as "adapted regulations" for the purposes of section 7A of the Act, subject to the provisions of regulation 4.
- 4. For the purposes of regulation 3, the Minimum Requirement Documents issued by the Fiji Regulatory Aviation Office as approved by the Solomon Islands Director of Civil Aviation shall apply with such modifications in construing and implementing the provisions of the aforesaid Order.

# THE CUSTOMS AND EXCISE (EXPORT DUTIES) (AMENDMENT) (NO. 1) ORDER 2003.

IN exercise of the powers conferred by section 7 of the Customs and Excise Act, I, SNYDER RINI, Minister of Finance, do hereby make the following Order:-

- 1. This Order may be cited as the Customs and Excise (Export Duties) (Amendment) (No.1) Order 2003 and shall come into force on the date of publication in the Gazette.
- 2. That part of the First Schedule to the Customs and Excise Act, entitled "EXPORT CLASSIFICATION AND TARIFF" is hereby amended in the following respect:
  - a) by amending the duty rate of 20% which appears in respect of tariff item No. 0305.0000 and substituting therefor 0%.
  - b) by adding immediately after tariff item No. "0305.0000 new tariff item No. 0305.7000 and inserting duty rate of "20%" as "Dried Shark Fin".
