# THE CUSTOMS AND EXCISE (IMPORT DUTIES) (AMENDMENT) (NO.6) ORDER 2003.

IN exercise of the power conferred by section 7 of the Customs and Excise Act, I, SNYDER RINI, Minister of Finance, do hereby make the following Order:-

- 1. This Order may be cited as the Customs and Excise (Import Duties) (Amendment) (No.6) Order 2003 and shall come into force on the date of publication in the Gazette.
