IN exercise of the powers conferred on me by section 2 (1) of the Local Courts Act, I Sir Albert Rocky Palmer, Chief Justice of Solomon Islands, hereby establish the GHORENA Local Court with jurisdiction in the area of any of the wards of the Gizo/Kolombangara Local Court, Simbo/Ranongga Local Court, Vella la Vella Local Court (constitution of wards) order.

- 2. The constitution of the Court Shall be as follows:-
 - (a) The Court shall consist of
 - (i) not more than 1 president;
 - (ii) not more than 5 vice president and each of whom may preside in place of the president; and
 - (iii) not more than 30 Members
 - (b) The Court shall be deemed to be duly constituted if it consist of not less than three members, one of whom shall be a president or vice - president and in the determination of causes and matters coming before the Court it shall be lawful for more than one Court as so constituted to sit at any one time.
 - (c) In the determination of any cause or matter the opinion of the majority of the members shall prevail.

- (b) offences against any law specified in any order made under section 9 of the Local Court Act, Cap. 19.
