## PRICE CONTROL ACT (Cap. 64)

# THE PRICE CONTROL (APPLICATION TO GOODS AND RESTRICTION OF PRICES) (AMENDMENT) (NO. 4) ORDER 2008.

IN exercise of the powers conferred by sections s4 and 6 of the Price Control Act, and after consultations with the Prices Advisory Committee, I, FRANCIS BILLY HILLY, Minister of Commerce, Employment and Trade, do hereby make the following Order –

1. This Order may be cited as the Price Control (Application to Goods and Restriction of Prices) (Amendment) (No.4) Order 2008 and shall come into operation on the 1st April 2008.

2. Schedule 3 to the Price Control (Application to Goods and Restriction of Prices) Order 1987\* is hereby amended by deleting serial No. 13 thereof and substituting therefor the following –

### "13 PETROLEUM PRODUCTS
